## FULL TURNKEY SOLUTION Coal Handling and Preparation Plant

PROJECT DETAILS

#### Overview:

Solid Energy New Zealand operates an open-cast coal mine on the Stockton Plateau, 35km north of Westport, on the West Coast of the South Island, New Zealand. The Stockton mine produces high-quality coal for export to the steelmaking industry.

As of 2008 the Stockton mine had accumulated stockpiles of up to 15 million tonnes of contaminated coal due to operating in areas of historic underground mining. A prefeasibility study conducted by Brightwater and Downer Engineering identified that a Coal Handling and Preparation Plant (CHPP) would produce 10 million tonnes of saleable high value product from this stockpile.

#### Solution:

Solid Energy engaged Brightwater as the principal contractor to design (in conjunction with Downer Engineering), procure, and manage the fabrication and construction of the NZ\$124 million green-fields Coal Handling and Processing Plant project, all within a fast-track schedule.

The coal handling and processing plant was designed to separate large volumes of high-value coal from rock, old underground mine propping timbers and other waste material, and washing and grading it. The Coal Processing Plant (CPP) was designed to handle between 600,000 tonnes and 1 million tonnes of coal a year. The two key processing steps in the CPP are a dense-medium cyclone for the separation of coarse coal (-60mm(ww) +1.4mm), along with three parallel circuits of hydraulic classifiers for the separation of fine coal (separation (-1.4mm (ww) + 0.045mm) minimising hazards.



HOLCIM AUSTRALIA



PROJECT DETAILS

#### Overview:

In a key strategic step to future proof the supply of construction materials to the Sydney metropolitan area, Holcim Australia commissioned the development of a Regional Distribution Centre (RDC) in the Sydney suburb of Rooty Hill. The RDC receives construction materials (sand and aggregates) via rail and stores these materials ready for distribution to Sydney based customers. The majority of the aggregate and sand product is provided by Holcim's newly built Lynwood quarry situated 160km south of Sydney.

#### Solution:

In May 2013, Brightwater was awarded the contract to deliver the full engineering design, construction, installation and commissioning of the facility to receive, unload, and store product delivered by rail. The entire project management, and design work, was carried out by Brightwater's New Zealand based staff.

Operating 24 hours a day, seven days per week, the facility can receive up to nine trains per week and unloads up to 2500 tonnes per hour. The project was completed in mid-2015 with final commissioning taking place during August 2015.

#### Overview:

Buller Coal Limited owns and operates all of Bathurst Resources Limited's operations on the Buller coal field, including 10,000 hectares of exploration and mining permits, the planned Escarpment Mine project and the operating Cascade mine on the edge of the Denniston Plateau.

As the capacity of their West Coast operations increased, Buller Coal explored options and solutions for the transportation of coal via the Port of Westport to the Port of Taranaki in New Plymouth. In particular a facility for the receipt of coal via road and eventually rail transport that would allow for the temporary storage and efficient ship loading of the coal.

#### Solution:

The solution needed to ensure the highest standards of operational Health & Safety, be economical, and scalable as volumes increase from an initial forecast of 200,000 tonnes of coal per annum to a potential 400,000 tonnes of coal per annum.

Brightwater was engaged to manage the Design, Engineering, Procurement and Construction phases of the project. The design and engineering team worked very closely with Buller Coal to ensure that the complex long term requirements for the facility would be met.

The design included an elevated ramp to allow trucks with tipping trailers to unload through a discharge grizzly into a bay for Front End Loader (FEL) transfer to the stockpile. The solution needed to incorporate existing facilities, in particular an existing ship-loading conveyor for off-loading from the facility.

The building had to have an initial operating capacity of +3000 tonnes with a stockpile height up to 5 metres. The building was designed to allow for an increased capacity of 9000 tonnes with the introduction of elevated mechanical in-feed and mechanical reclaim.



## FULL TURNKEY SOLUTION Water Treatment Plant

YASHILI NEW ZEALAND



PROJECT DETAILS

#### Overview:

Yashili is one of the leading infant formula producers in China. In 2014 Yashili developed a 8mt/hour Infant Milk Formula facility in Pokeno, north Waikato.

Brightwater was contracted to deliver a potable water plant capable of treating and producing 3,000m3 of water per day. Yashili acquired resource consent to receive raw water supplied from a bore adjacent to Yashili's property. This raw water presented its own challenges being high in iron and manganese and extracted from the ground where it's remained for over 150 years.

Additionally, Brightwater was contracted to design the building which contained the plant, associated civil design for the adjacent Waste Water Treatment Plant and supply various ancillary equipment required for the water treatment area.

#### Solution:

Brightwater along with technology partner Ixom Australia, were tasked to deliver a complete engineering, procurement and construction (EPC) water treatment facility. Brightwater worked closely with Yashili throughout the design stage to ensure the finished product would meet their unique requirements.

The final plant comprised of innovative media filtration technology, when coupled with Chlorine Gas chemical dosing, was able to treat the water within spec without altering the incoming pH. This was a major advantage over standard green sand filters and was engineered to be a substantial cost saving for Yashili's annual chemical inventory. This also allowed the reduction in size of the associated storage tanks and the equipment required for dosing and pH control. The solution presented further benefits with the raw water constantly changing composition and having no effect on the potable water end product.

In addition to this, Brightwater also developed and constructed a softening plant using advanced long life resins and a full Salt Saturator regeneration system.
